ONLINE ENTRIES www.dogoffice.cz Applications must be submitted online via electronic system www.dogoffice.cz. All accepted applications are confirmed by entry tickets. To create an account in the Dogoffice system is the first step. Then insert your dog into the section MY DOGS and add copies of both sides of the dog's pedigree including the part with clearly and visibly stated name of the owner into the section DOCUMENTS. In this section copies of working certificates or championship diploma for inclusion in the working or champion class should be added. If these documents have not been inserted, the class is automatically changed into Open.

After a successful registration you receive a confirmation message and your application status appears in the section „APPLICATIONS“. After completing your registration, the system generates a variable symbol for your payment. The application is valid if it has been paid.

Postal orders type C are not accepted.

Application completing:

Each dog has its own application. If the application is completed incorrectly organizer of the show is not responsible for it. For valid application, the entry form must include a photocopy of both sides of pedigree. In the case of a payment by postal service, support the entry form at least by a photocopy of payment. A dog can be entered only in one class and any other changes are not allowed. Acceptance of a dog to the show will be electronically send to your e-mail address about ten days before the show. If you don't receive the confirmation, please contact the show office. An exhibitor agrees with publication of his address in the catalog.

Documents for participation at the show:

- Pedigree
- EU Pet passport
- . Entrance leaf

Classes: division into classes is done according Show Regulation of CMKU and FCI and is indicated on the entry form. Color, sizes and type of hair of some breeds are judged separately in compliance with the provisions of FCI or by decision by ČMKU. Awarding of titles can not be entitled.

Expectancy: CAJC, CAC ČR, CAC ČMKU, Res. CAC ČR, CACIB, Res. CACIB, CACIB-J, CACIB-V

Titles: Best of Minor Puppy, Best of Puppy, Best of Breed – BOB, Best of opposite sex – BOS, Best Junior in breed – BOJ, Best Veteran of breed – BOV, Junior Winner of FCI – JBIG, Junior Winner at the show – JBIS, winner of FCI group – BIG, winner of the show – BIS.

Competitions:

Junior Handling – age groups: I. The age of 9 - 13, II. The age of 13 - 18, Participants must achieve demanding age one day before the date of show. **Only dog registered in the stud book recognized by the FCI** can take part in competition, however the dog need not be judged at the show. Assesses the performing dog quality is not important. Points earned in competition at national and international exhibitions may count yearlong, statewide competition.

Best Minor Puppy – To enter the competition, best mala or female from the competition advances very promissing I.

Best Puppy – To enter the competition, all male or from the competition advances very promissing I.

Best Veteran – competition of dogs which received the title Best Veteran BOV.

Best Couple – a male and a female of the same breed and variety, presented at the show, owned or co-owned by the same person(s). The co-ownership must be confirmed by a record in the pedigree.

Best Breeder's Group – 3 – 5 individuals of the same breed and variety, which have been judged at the show, which come from the same kennel and which have at least two different fathers or mothers.

Junior Group Winner (JBIG) – competition of FCI groups. For all dogs which received the title BOJ

Group Winner (BIG) – competition of dogs with title BOB, judging according groups FCI

Junior Best of Day (JBOD) – competition of dogs, which won JBIG Best of Day (BOD) – competition of dogs, which won the FCI groups

Junior Best in Show (JBIS) – competition of winners JBOD

Best in Show (BIS) – competition of dogs which won BOD

Veterinary conditions:

- All entered dogs must be clinically healthy.
- Dogs must have pet passport or veterinary certificate with valid vaccination against rabies.
- Dogs from EU countries and the third countries must have valid EU Pet Passport must meet conditions according the EU Regulation 998/2003 from 26/5/2003
- During the dog show, the owners have to supervise their dogs not to cause any damage to other dogs or people.

General provisions:

The exhibition is accessible to males and females of all breeds registered in the books recognized by the FCI that reached the day of the show the age required for class. Organizers are not responsible for damages caused by a dog or an exhibitor, for dog loss or death during the exhibition. The owner must supervise the dog all the time, dog is not allowed to move on its own. A random inspection of the identity of dogs (tattoo nr./chip) according to the regulations of CMKU can be done during the show. **Dogs with cropped ears are not allowed to enter to the show area and cannot be judged.** Show is not open for females in the second half of pregnancy, nursing females and aggressive individuals. It is forbidden to treat the coat, skin or nose or to change their texture, colour or shape. It is forbidden to treat the dog at the show grounds using any substances or equipment. Only cutting, trimming, combing and brushing can be done. It is also forbidden to tie dog to the table at the show. Breaking of this rule may result in immediate expulsion from the show. Owners of the dogs awarded the title BOB are obliged to participate with their dogs in the final competitions. Exhibitors are required to comply with the provisions of the FCI Show Regulations and ČMKU, these propositions and the instructions of Show Committee, which will undertake the filing. Exhibitor acknowledges that they are obliged to maintain order in the exhibition area. If the show does not take place due to force majeure, the fees will be used to cover the expenses. Selling puppies at the show is prohibited. Organizer assumes no responsibility for not delivery entryforms. **If more than 80 dogs are entered for the judge, there is no need to write show reports after agreement with the organizer.** Changing of the judges can be done. Exhibitors at the CMKU show are responsible for the welfare of dogs. It is forbidden to expose dogs to a situation that could endanger their health or well-being. For example leaving a dog in a vehicle under high or low temperature. Violations of this Regulation will result in exclusions from the following exhibitions. Taking photos at the show is allowed, as well as the visitors agree that they could be objects of taking photos. If not, they can express their disagreement.

Protest:

A protest against any judge decision made is not admissible. A protest can be submitted because of formal reasons such as violation of show regulation. The protest must be submitted in written form, against a deposit of 110 EURO /only during the show/. If protest is considered to be unjustified, deposit belongs to the show organizer .
